1. **HOW TO PARTICIPATE:** Beginning at 8:00 a.m., ET, August 10, 2026, through 11:59 p.m. ET, September 8, 2026, visit www.unitedwayatlanta.org/raffle and follow the on-screen entry instructions. Your entry will automatically be included in the random prize drawing described below, subject to eligibility requirements. By entering, you certify that you are **eighteen (18) years of age or older** at the time of entry.

Participants may obtain entries by making a qualifying donation as follows:

- Each entry costs \$1 (one dollar)

All entries must be submitted through the official raffle website and received during the promotional period.

2. **ELIGIBILITY:** All entries must be completely filled out and submitted within the days and times indicated above in order to be eligible. This raffle promotion is open only to legal residents of the State of Georgia, **who are eighteen (18) years of age or older at time of entry**.
